

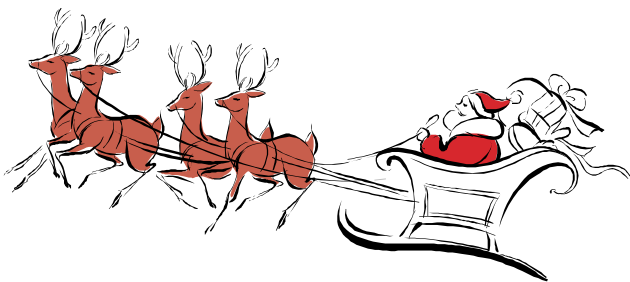

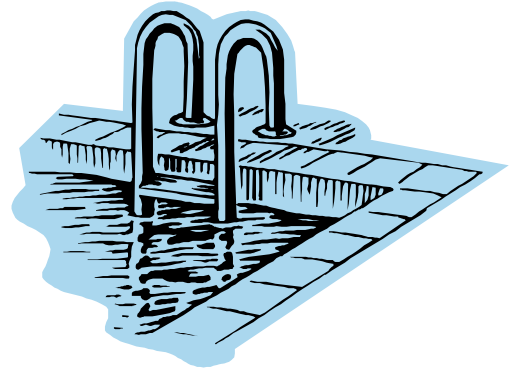
*News Around Glen Burnie....*

**North Arundel Aquatic Center**

The North Arundel Aquatic Center opened in September and is a beautiful facility. Located at 7888 Crain Highway, this new pool has something for everyone. The leisure pool is fun for children and adults. It contains a two 20-yard lap lanes and an indoor water park. The features of the water park include: a pre-school water slide, a vortex area, water buckets, a splash down area, a 134 foot water slide and a pool-side spa. In addition to the leisure pool, the facility contains a competition pool with 8 lanes for lap swimming. The pool hours are Monday — Friday 6 a.m.-9 p.m., Saturday 7 a.m.— 8 p.m. and Sunday 10 a.m.—6 p.m. The water features are not on continuously. From Monday — Friday they run from 4 p.m. — 8 p.m., on for 45 minutes, off for 15 minutes. Call for weekend water feature hours. Admission fees are as follows:
