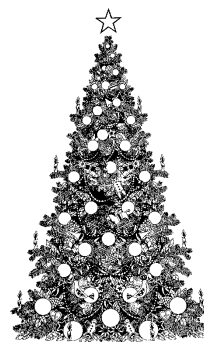

## GBIA Annual Tree Lighting

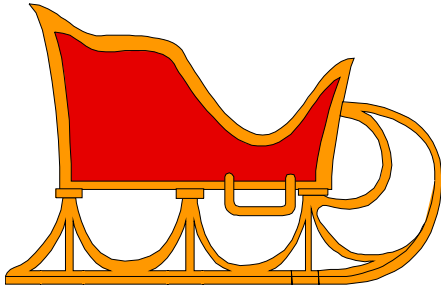
This year the GBIA tree lighting was held on a Friday evening and the turn out was great. The evening began with singing of a few Christmas

## Glen Burnie Town Center Ice Rink



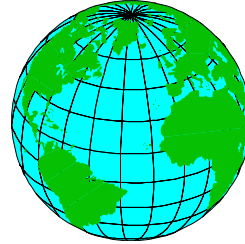
The Ice rink is open and ready for lots of skating and fun to be enjoyed by all.
